

**Facebook Pot of Gold Giveaway

**Official Rules**

1. Ada Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Ada Gaming Center is giving away Bonus Play and prizes for the “Facebook Pot of Gold Giveaway” promotion on Friday, March 8, 2019.
2. Patrons must be and 18 years of age or older with a valid photo I.D. and must be or become an Ada Gaming Center Players Card member, with complete and accurate account information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Ada Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Starting Monday, March 4, 2019 at 8:00am to Friday, March 8, 2019 at 12:00pm patrons can comment to win on the Ada Gaming Center’s Facebook Pot of Gold Giveaway post to be eligible for a chance to win the following:

  - c.) \$25 in Cash
4. On Friday, March 8, 2019 at 12:00pm one (1) name will be drawn.

Any such decision shall be final and binding on all patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
