## Ada Gaming Center

### Official Rules

1. Ada Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Ada Gaming Center is giving away \$5,000 in cash throughout the “Green Christmas” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. The following individuals or entities are not eligible to participate or win during this promotional activity: Employees of Ada Gaming Center; Employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. On Fridays December 7 and 14, 2018 ten (10) hot seat drawings will be held from 6:00pm until 10:00pm, and total of \$5000 in cash will be given away as seven (7) \$100, four (4) \$200, four (4) \$300, and two (2) \$400 and three (3) \$500. Ten (10) cash prizes will be chosen winners on December 7 and the remaining ten (10) will be chosen on December 14.
  - a. Patrons must be present and actively playing an electronic gaming machine at the time of each drawing to be eligible to win.
  - b. Hot seats will be drawn by random bank and machine numbers.
  - c. Patrons will select on item from a random arrangement and will receive the prize inside.
  - d. Limit of one (1) prize per patron, per night for the duration of this promotion.
  - e. Ada Gaming Center’s manual drawing system will be the sole determinant of the bank and machine drawn for each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
