Official Rules

1. Ada Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Ada Gaming Center is giving away featured gifts every month for the “Gift of the Month” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be an Ada Gaming Center Players Club Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Ada Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. During the months of October, November and December, between the dates of ; 10/1-10/3, 10/8-10/10, 10/15-10/17, 10/22-10/24, 10/29-10/31, 11/5-11/7, 11/12-11/14, 11/19-11/21,11/26-11/28, 12/3-12/5, 12/10-12/12, 12/17-12/19, and 12/24-12/26, qualified patrons who earn sixty (60) points while playing with their Ada Gaming Players Club Card may redeem for a featured gift item while supplies last. (Gifts Valued between \$18.99 and \$49.99)
 - a.) Patrons must earn points on their Ada Gaming Players Club Card by playing Electronic Games during the qualifying time period, The Qualifying time period starts at 8am the first day of each time period and ends at 11:59pm on the last day of each time period, and report to the Players Club or cashier cage.
 - b.) Patron(s) must be present to redeem.
 - c.) Limit of one (1) gift per patron per weekly date range.
 - d.) Management of Ada Gaming Center may substitute prior gifts for the current month’s gift, based on availability and Management discretion.
 - e.) Ada Gaming Center’s casino management system will be the sole determinant of each winner.
 - f.) Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are eligible to redeem these offers for additional entries.

4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released, when applicable.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
