

# AGC Going Buck Wild

## Ada Gaming Center

### Official Rules

1. Ada Gaming Center is a governmental enterprise of the Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Ada Gaming Center is giving away \$7000 in cash and prizes throughout the "AGC Going Buck Wild" promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and be an Ada Gaming Center Players Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Ada Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation's policies, regulations, or laws; anyone who has been barred from any of the Nation's gaming facilities; or any promotional sponsors
3. Hot seat drawings will be held on August 28, September 11, and September 25, 2021, from 6:00 p.m. to 10:00 p.m. each night. Fifteen (15) preliminary cash prize winners will be drawn each night, and preliminary cash will be given as; fifteen (15) \$100. Grand Prizes will be awarded each night at approximately 10:00 p.m. and will be given as follows; one (1) \$500 Bailey's Outdoor Shop Gift Certificate on August 28, one (1) \$500 Bailey's Outdoor Shop Gift Certificate on September 11, and one (1) \$1500 Bailey's Outdoor Shop Gift Certificate on September 25.
  - a. Patron(s) must be present and actively playing on a participating electronic gaming machine at the time of each drawing to eligible for random selection.
  - b. To qualify as "actively playing", a Patron must be seated at an electronic gaming machine at the time of each drawing and have placed a wager at that machine within five (5) minutes of the drawing time.
  - c. The winner(s) will be announced and given two (2) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
  - d. All participating patrons will be eligible for the Grand Prize at 10:00 p.m. each night.
  - e. Limit of one (1) preliminary win per patron, per night during this promotion. Limit of one (1) Grand Prize per patron for the duration of the promotion.
  - f. Ada Gaming Center's manual drawing system will be the sole determinant of each winner.
4. Casino Management reserved the right to ask Patrons who are not actively playing to relinquish their electronic gaming machine.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form when applicable provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. The winner(s) must agree to sign a publicity release form before the prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be

final and binding on all Patrons. Also, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from gameplay, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies, and courts without limit to time or event, which shall govern this promotion.
