

# ROLLING in RICHES

## Ada Gaming Center

### Official Rules

1. Ada Gaming Center is a governmental enterprise of the Chickasaw Nation (“Nation”) a federally recognized sovereign Indian tribe. Ada Gaming Center is giving away up to \$10,000 in cash throughout the “Rolling in Riches” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be an Ada Gaming Center Player’s Card member, with complete and accurate account information, The following individuals or entities are not eligible to participate or win during this promotional activity: Employees of Ada Gaming Center; Employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Random carded hot-seat drawings will be held from 6:00 pm until 9:00 pm on Thursdays, January 13, 20, 27 and February 3 and 10. A share of \$2,500 in cash will be given to a total of ten (10) winners each night. The prize amount will be determined by playing one hand of a dice game.
  - a. One hand consists of up to three (3) throws of up to five (5) dice. Hands will be paid as follows:
    - i. Three of a kind - \$50
    - ii. Four of a kind - \$75
    - iii. Full House - \$125
    - iv. Small Straight (four (4) consecutive numbers) - \$150
    - v. Large Straight (five (5) consecutive numbers) - \$200
    - vi. Five of a kind - \$250
    - vii. All other hands - \$25
  - b. Patron(s) must be actively playing with their Ada Gaming Center Player’s Club Card at the time of each drawing to be eligible for a cash prize.
  - c. Patrons must be present to win. Winners will have two (2) minutes to respond before a new winner is drawn.
  - d. In order to qualify as “actively playing”, a Patron must have their Players Club card properly inserted in an electronic gaming machine at the time of each drawing and have placed a wager at that machine within five (5) minutes of the drawing time.
  - e. Ada Gaming Center’s casino management system will be the sole determinant of each winner.
  - f. Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are eligible to redeem these offers for additional entries.
4. Each night, if needed, one final Grand Prize winner will be drawn to receive all monies not previously awarded (if any available).
  - a. All patrons are eligible for the Grand Prize drawing.

5. Casino Management reserves the right to ask Patrons who are not actively playing to relinquish their electronic gaming machine.
6. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form when applicable provided by the Chickasaw Nation.
7. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. The winner must agree to sign a publicity release form before the prize will be released.
8. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. Also, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from gameplay, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and forfeiture of any prizes.
10. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies, and courts without limit to time or event, which shall govern this promotion.
