

Holly Jolly Hot Seats

Official Rules

1. Ada Gaming Center is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Ada Gaming Center is giving away over \$8,000 in cash and prizes during the “Holly Jolly Hot Seats” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Ada Gaming Center; employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. On Thursdays, December 1, 8, 15, and 22, 2022, Ada Gaming Center will be hosting hot seat drawings for a chance to win a share of over \$2,000 in cash and prizes from 6:30 pm to 9:15 pm. Each night, Ten (10) winners will be drawn each night. Preliminary prizes include cash will be given as four (4) \$50, two (2) \$75, one (1) \$100, and two (2) \$200. Each prize will be selected by choosing a gift (values from \$14.99 - \$70.00). At approximately 9:15 pm each drawing night, one Grand Prize winner will receive one (1) \$400 cash prize and one (1) pair of Oakley Sunglasses (values from \$146 - \$167).
 - a. Patron(s) must be present and actively playing to be eligible for drawings.
 - b. In order to qualify as “actively playing”, a Patron must be seated at an electronic gaming machine with a playable amount of credits (in accordance with the machine’s minimum playable wager) at the time of each drawing.
 - c. Winner(s) will be announced and have one (1) minute to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
 - d. Winners will have the opportunity to randomly choose their preliminary cash or prize from a themed prop.
 - e. Limit of one (1) preliminary prize per patron, per night during the promotion. Limit of one (1) Grand Prize per patron for the duration of this promotion.
 - f. Ada Gaming Centers’ casino management system and manual drawing system will be the sole determinants of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
